

## Scholarships and Criteria

### 100 Women Project Endowment Scholarship

Requirements:

1. Must be a Female student
2. Must be a non-traditional aged student (23 years or older)
3. Preference given to a student who has a SCCC GPA of 2.5 or higher
4. Preference given to students who demonstrate financial need
5. An additional essay (250 word maximum) must be submitted with this application.  
The subject of the essay to be "Why do you think it is important to be an educated woman?"  
Please include in your answer one of the following:
  - What do you think is the biggest obstacle to women in achieving their professional or personal goals?
  - What do you think, as a woman, you will bring to your professional life?
  - Who is your female mentor or role model, and why?

### 200 Club of Sussex County Annual Scholarship

Requirements:

1. Must be a high school senior or SCCC student who is a dependent child of a parent who actively serves (or at the time of death, actively served) as one of the following.
  - Law enforcement officers, firefighters, members of emergency medical first aid squads or members of emergency management, working (whether on a volunteer or paid basis) in Sussex County.
  - New Jersey State Police, residing or working in Sussex County.If both parents are deceased, then the applicant must be less than 21 years of age. Children of personnel working in clerical or other non-related public safety duties are not eligible.
2. Must be a resident of Sussex County.
3. Must be pursuing a degree in law enforcement or public safety.
4. Must be a full-time student.
5. Must have exhibited good citizenship traits and be of sound moral character.  
**(Please note this in your essay.)**
6. Children of voting members of The 200 Club are not eligible for this scholarship.

### 9/11 Memorial Annual Scholarship

Requirements:

1. Preference given to students who demonstrate financial need
2. Must prepare and attach a separate essay on "What 9/11 means to me"  
**(This is in addition to the required essay)**

Requirements:

1. Must have a SCCC GPA of 2.5 or higher.
2. Must be a resident of Sussex County.

### **William Pierce Sr. Memorial Endowment Scholarship**

Requirements:

1. Preference for a Sussex County resident
2. Student must demonstrate financial need.
3. Study in the area of Fire Science, Criminal Justice or any public safety area
4. Preference will be given to a volunteer Fire Fighter ***(Please mention this in your essay.)***

### **William S. Finch Endowment Scholarship**

Requirements:

1. Must have a SCCC GPA of 2.5 or higher
2. Preference given to students who demonstrate financial need

### **Zonta Endowment Scholarship**

Requirements:

1. Preference given to students who demonstrate financial need
2. Must be a returning adult female student, non-traditional aged (23 years or older) who is seeking a new career and/or beginning a career for the first time after many years of either working at a low paying job, or who has been a homemaker and now wants to further her education in order to seek a career
3. Must have a SCCC GPA of 3.0 or higher
